***Last night at the June 12, 2017 board meeting, the Board of Trustees approved a lateral transfer for Mr. Zamudio to a position as Principal on Special Assignment. The transfer is effective June 14, 2017.***

***We plan to post the Olympian principal position as soon as possible.
