Your comments have been considered.

Without conceding or admitting to the accuracy of your factual allegations, arguments, or comments, the District is undertaking the following actions:

The deadline of disclosure to the Voice of San Diego reporter has been extended from January 10, 2018, to Tuesday, January 23, 2018. If that requestor objects to that extension, you will be informed.

Correspondence will be forwarded to the requestor's attorney (Felix Tinkov) in an attempt to not disclose the documents involving your client. If you wish to communicate with him directly, feel free to do so. If you wish any comment to be included into our correspondence to that attorney or any of his co-counsel, generically (without identifying your client's name), please submit to me that request by the end of the business day Wednesday, January 17, 2018. (If your comments are included – no promise - they would likely be prefaced with a comment such as, "The following comments have been provided by an attorney representing one of the employees whose documents are at issue...") You will be informed of the response by the requestor's attorney, if any and if disclosures are still requested.

Meanwhile, if despite this communication, litigation is filed within the "Marken" option, you are requested to notify Rita Beyers no later than the end of the business day Wednesday, January 17, 2018. Please also send a courtesy copy of the litigation to me as service is made upon Coronado Unified School District. Thank you.
