Dear Mr. Cadieux:

Your correspondence of December 26, 2017 was received, as well as your message last Friday, January 5, 2018. A reply has been delayed due to the holiday break of my client.

Your comments are being considered.

In terms of the scope of the PRA request, an attorney representing the requestor has clarified that the term "sexual misbehavior and related misconduct" is to be interpreted in its broadest scope, including by way of his examples, pervasive or singular acts of sexual harassment, including unsolicited or unwelcome workplace flirtations with students.

You are also reminded of the comments in the correspondence of December 15, 2017, which indicated the District's intent to disclose the information unless Rita Beyers is informed in writing or electronically by the close of business Monday, January 8, 2018, that an action has been filed to block the disclosures of any of those documents and that she be provided a copy of that court action before January 10, 2018. HOWEVER, I HAVE AUTHORITY TO EXTEND THOSE DEADLINES TO January 12, 2018.

Any further information or comments you provide will be considered, within the above context and the context of the December 15, 2017 correspondence.
