Re: <u>DEMAND FOR IMMEDIATE DISMISSAL</u> Figueroa v. Fletcher, et al.; Case No.: 37-2023-00012828

Dear Counsel:

This is a formal demand that your client immediately dismiss this entire lawsuit against our client. Grecia Figueroa has always known that she was never sexually assaulted or harassed by Mr. Nathan Fletcher and that she was terminated by MTS due to her own poor job performance. Yet, through assistance from her attorneys, she has perpetuated an outrageously false tale to obtain a seven-figure settlement, all while strategically withholding countless exculpatory facts from the public and making intentional misrepresentations to the Court.

The evidence proves – beyond any doubt – that Ms. Figueroa was the aggressor in her interactions with Mr. Fletcher. It shows that she initiated social media communications with him, asked him to always message her first, and spoke to him in erotic tones. She flirted with him, dreamt about him, and, eventually, desired oral sex with him (which Mr. Fletcher declined).¹ She promised him she was comfortable and told him she enjoyed their encounters. After *each* of the three purported incidents of sexual assault referenced in the Complaint, Ms. Figueroa eagerly and voluntarily sought more opportunities to meet with him privately. She stated that she "missed his lips", practiced "*not* thinking about kissing his face," wished he was physically with her in her bed, and asked that he bring her gifts and celebrate her birthday (all which Mr. Fletcher declined). Nevertheless, evidence of consent is overwhelming and abundant, and is summarized in detail below. The entirety of their communications are attached for your office to re-review.

Additionally, the evidence also shows that Mr. Fletcher played no part in Ms. Figueroa's termination from San Diego Metropolitan Transit System. She has always known – and has now admitted under oath – that he was not her employer or direct supervisor. He had no authority to hire her, pay her salary, determine her work schedule, or promote or terminate her employment. She has conceded that "her job required very little, if any, direct interaction" with him and there is

¹ Ms. Figueroa has admitted, under oath in her discovery responses, that she never had sexual intercourse or oral sex with Mr. Fletcher. For his part, Mr. Fletcher never communicated an intent or interest in having sex, often expressed hesitancy and disinterest when responding to Ms. Figueroa's flirtations, and repeatedly re-affirmed that she remained comfortable.

no evidence suggesting any workplace harassment, violence, or retaliation against Ms. Figueroa by Mr. Fletcher, or by anyone else. The evidence is clear that she was a poorly performing employee who was terminated following numerous warnings from her supervisors.

Despite the evidence, Ms. Figueroa publicly declared that "*nothing* about [her interactions with Mr. Fletcher] was consensual",ⁱ that she had "all the proof" to support her salacious allegations;ⁱⁱ that she would produce evidence that was "damning [as fuck]",ⁱⁱⁱ and that she was owed a public apology.^{iv} Each of these statements proved to be false, but her fictitious story was still repeated millions of times, garnered state-wide attention, and immediately destroyed Mr. Fletcher's hard-earned reputation and career. *He and his family sustained permanent, emotional and economic harm due to her false allegations*. Unfortunately, none of it was accidental and all of it was by Ms. Figueroa's design.

From the beginning, Ms. Figueroa and her team of attorneys possessed all necessary evidence to understand that this lawsuit was entirely without merit. Still, they chose to repeatedly re-publish her false allegations in three separate complaints. Alternatively, Mr. Fletcher has always truthfully acknowledged that he made a personal mistake within his marriage, but that he did not engage in any legal wrongdoing. Evidence supporting his position is undeniable. For these reasons, <u>Ms. Figueroa and her counsel</u>, <u>Zachary Schumacher</u>, <u>Zachary Freire-Avina</u>, <u>Jessica</u> Pride, and Dante Pride have maintained this lawsuit in bad faith and for malicious purposes.

As a result, this correspondence represents our formal demand that Ms. Figueroa immediately dismiss all of her claims against Mr. Fletcher, with prejudice. Please also accept this meet and confer letter as formal notice that all forms of relief – including a Motion to Strike and/or Demurrer – will be pursued against Ms. Figueroa and her attorneys, should she persist with this public charade and continue to inflict emotional and economic damage on Mr. Fletcher through her knowingly false allegations. Our position and demand are detailed fully below.

1. A Crumbling Façade: Ms. Figueroa's False Narrative and Deceptive Legal Strategy

On March 28, 2023, Ms. Figueroa falsely claimed that Mr. Fletcher sexually assaulted her during her employment with the San Diego Metropolitan Transit System,^v and that her termination was motivated by his campaign for the California State Senate.^{vi} Ms. Figueroa demanded that she be believed and lamented that the phrase "believe women" was often exploited as a "facade" to advance one's own self-interest.^{vii} She referenced being called "a liar, a mistress, a gold digger, and far worse names," but cautioned that conclusions should not be drawn "before a single piece of evidence has hit the courtroom."^{viii} She initially invited "accountability" and "transparency" in this case.^{ix}

Despite Ms. Figueroa's grand pronouncements, she and her attorneys have known – **from the beginning** – that her claims lack legal and factual support. Ms. Figueroa downloaded her entire Instagram communications with Mr. Fletcher on or around <u>February 16, 2023</u>, over a month before this lawsuit was filed.^x She later created a screen-recording that imaged all of her communications as they visually appeared on the Instagram app. These messages show that she

was an eager and voluntarily participant in her interactions with Mr. Fletcher.² Mr. Schumacher used *dozens* of these messages – out-of-context – to concoct an intentionally misleading and inflammatory narrative that falsely portrayed Ms. Figueroa as an un-consenting victim of sexual assault and battery. When Mr. Fletcher rejected her fictitious story and refused to submit to her exploitative financial demands, Ms. Figueroa filed her Complaint in retaliation.

After the Complaint was filed, Mr. Fletcher formally requested – at his first opportunity – that the entirety of the Instagram communications be produced in discovery. Despite Ms. Figueroa's calls for "transparency," she took every possible action to prevent production. Her new attorneys, The Pride Law Firm, refused to produce a <u>single</u> document; falsely withheld production under the guise of a nonexistent protective order; and attempted to quash a subpoena to Meta Platforms, Inc. that independently requested the messages. After Mr. Fletcher was forced to seek a court order to obtain the relevant evidence, The Pride Law Firm – and specifically, Mr. Zachary Freire-Avina – falsely represented to the Court that *all* of Ms. Figueroa's communications had *already* been produced, when in-fact, over <u>100+ pages</u> of documents were still being withheld.^{xi} Such conduct was inappropriate and directly contrary to Ms. Figueroa's supposed interest in "accountability" and "transparency."

We now understand why Ms. Figueroa so strongly resisted production of her communications with Mr. Fletcher. The documents revealed that the Complaint perpetuated a **false** narrative – unsupported by any credible facts or documents – seemingly for the purpose destroying Mr. Fletcher's political career and family and allowing Ms. Figueroa to enjoy fifteen undeserved minutes in the public eye. Indeed, the documents fully exonerate Mr. Fletcher and, in the Court's own words, go "to the very core of [Ms. Figueroa's] claims against him."^{xii}

Now, the façade of Ms. Figueroa's story is crumbling. *Mere hours* after the evidence was finally ordered to "hit the courtroom," Mr. Schumacher withdrew his representation from the case. The Pride Law Firm was also heavily sanctioned by the Court for refusing to produce the **120** pages of documents that Ms. Figueroa downloaded on or around February 16, 2023. For these reasons, it is obvious this case is a sham: Ms. Figueroa was not sexually harassed or assaulted by Mr. Fletcher, nor did he play any part in her employment or termination. Every interaction was consensual. Ms. Figueroa and her team have known these facts from the beginning but continue to prosecute this lawsuit knowing the harm they cause.

2. Incident by Incident Analysis: Ms. Figueroa was Never Sexually Assaulted

The Pride Law Firm's general litigation practices are extremely concerning. Judge Matthew Braner recently held that allegations in other lawsuits filed by The Pride Law Firm were so "<u>objectively unreasonable</u>" that severe sanctions were warranted to deter similarly unreasonable conduct in the future.^{xiii} A sworn, public declaration filed in that same case also revealed that The Pride Law Firm allegedly admitted during a phone call that "**We don't care if we get damages. We are going to get <u>publicity.</u>"^{xiv} In other proceedings, motions and related-terminating sanctions have been requested against The Pride Law Firm for "disregard for**



discovery obligations, a refusal to engage in good faith meet-and-confer efforts, and a blatant disregard for a court order."^{xv}


Unfortunately, despite these troubling occurrences, The Pride Law Firm has continued its pattern of improper litigation tactics in *this* case by continuing to perpetuate objectively unreasonable allegations, seemingly for the purposes of smearing Mr. Fletcher for publicity. In particular, The Pride Law Firm repeatedly re-published Ms. Figueroa's narrative in multiple amended complaints, *including* a Second Amended Complaint ("SAC") filed on December 13, 2023. In doing so, they also continued to rely on dozens out-of-context communications.^{xvi} For this reason, we must now set the record straight: Each of the three purported incidents of sexual assault referenced in Ms. Figueroa's Second Amended Complaint are provably false.

Alleged Incident #1: Hotel Encounter on May 12, 2022


The SAC first **falsely** alleges in Paragraphs 30-33 that Ms. Figueroa was "shocked and confused, but [felt] powerless to say no…" when Mr. Fletcher supposedly "lured" her to his hotel on May 12, 2022. The SAC states that he "convinced" her to visit after "feeling a bit impulsive." (SAC ¶30). In support of these allegations, the SAC selectively incorporated a screenshot depicting 14 out-of-context direct messages. (SAC ¶ 31):




In reality, *hundreds* of written communications between Ms. Figueroa and Mr. Fletcher were wrongfully omitted from the SAC because they undermine these allegations. These messages occurred in the days immediately preceding their May 12th encounter and included over **100+ messages** transmitted that same day. In these communications, Mr. Fletcher and Ms. Figueroa <u>mutually flirted</u> with each other, <u>expressed consent</u> to each other, and jointly planned their first private meeting. On May 2, 2022, Ms. Figueroa "<u>promised</u>" she would not be communicating with Mr. Fletcher if she felt uncomfortable. On May 12, 2022, they each again confirmed that they were still comfortable with their interactions, with Mr. Fletcher specifically conditioning any meeting on Ms. Figueroa being "<u>completely comfortable</u>". In response, she described their interactions as "actually fun":



Similarly, contrary to the SAC's claim that Mr. Fletcher "convinced" and "lured" Ms. Figueroa to his hotel, it was *Ms. Figueroa* who affirmatively stated that Mr. Fletcher "<u>needed</u> <u>company.</u>" She wrote this after learning that he was home alone. The following morning, she also invited him to "<u>always</u>" initiate texting, even after he apologized for being flirty and suggestive:



Shortly after being invited to initiate text messaging, Mr. Fletcher suggested that they find a time where Ms. Figueroa could "stop by and say hello." In response, she stated "I'd like that...but is it risky though?" Mr. Fletcher replied they would have to be "careful" and "100% discreet", so long as Ms. Figueroa remained comfortable. She unambiguously consented to the encounter by inviting him to "find a day and time" to meet; stating that she would "follow [his] lead"; declaring that she trusted him; and acknowledging they both would need to be careful and discreet to mitigate any risks. Obviously, this exchange is vastly different from the SAC's false narrative that Mr. Fletcher unilaterally "insisted" that Ms. Figueroa keep the interaction "very 'discreet'." (SAC ¶28). Immediately therafter, Ms. Figueroa gave him the nickname "Papasito" (meaning "Little Daddy") and sent a flirtatious 23-second audio recording. Curiously, she and The Pride Law Firm continue to refuse to produce the recording in discovery, or even acknowledge its existence^{xvii}, despite a Court Order. Such conduct again suggests that Ms. Figueroa and The Pride Law Firm understand that this lawsuit is meritless and based entirely on misrepresentations about the nature of the relevant interactions. The communications are clear that Ms. Figueroa was a full, active, and willing participant in her encounters with Mr. Fletcher, contrary to the SAC's false allegation that she only "mimiced his erotic tone because she was afraid" (SAC ¶ 38):



Within this context, Mr. Fletcher and Ms. Figueroa continued to flirt and coordinate an inperson meeting. After some back and forth, they mutually coordinated a meeting in a stairwell at Mr. Fletcher's hotel. Still, <u>Mr. Fletcher re-emphasized that there was "no pressure" to meet</u> and

they both asked *each other* if they were "feeling impulsive," contrary to the SAC's suggestion that *only* Mr. Fletcher had the feeling. Such facts were intentionally omitted and/or misrepresented in Paragraphs 30-32 of the SAC to create a **false** narrative regarding the true nature of their mutual and consensual interactions:



On her way to meet him, Ms. Figueroa lied to her friend about her true whereabouts, before continuing to joke with Mr. Fletcher about the discreet nature of their interactions: (May 12, 2022, 9:34 PM. See Pltf Comm_00075)

Are you feeling impulsive??


Deal! But not until after 10!

What kind of beer do you like?

I'm parking down the street at my friendsI said I'm going to a bar lol
Stairwell bar:) Hahaha
It's the hot place
So discreet

Once Ms. Figueroa arrived at the hotel, she chatted with Mr. Fletcher in the stairwell for approximately 2-3 hours. At the end of the encounter, they briefly kissed each other. The Second Amended Complaint **falsely** suggests that this interaction was unwelcome and/or nonconsensual.

In reality, Ms. Figueroa's messages demonstrate that she was excited about what occurred. For example, she texted "<u>What a night!</u>" immediately after arriving back home. Several days later, on May 16, 2022 and in response to Mr. Fletcher asking "how are you?", she replied that she "<u>missed [his] lips</u>". She further stated that she would need to practice "<u>totally not thinking about kissing his face right now</u>" prior to an upcoming press conference. This is hardly the type of reaction one would have after a supposed sexual battery or assault. Indeed, such overt and mutual flirtations directly contradict the narrative in the SAC regarding the supposed one-sidedness of the subject interactions:




Given the evidence above, it cannot be reasonably disputed that Ms. Figueroa and Mr. Fletcher were mutual, consenting participants throughout the entirety of their encounter at his hotel on May 12, 2022, as well as in all the days that followed. They each participated in planning


the meet-up; they each flirted with each other; they each expressed attraction to each other; they each acknowledged feeling impulsive; they assured each other that they were both comfortable; and they each expressed excitement and enjoyment *after* they left each other's presence. There is nothing in these communications that even remotely suggests Mr. Fletcher's conduct was unwelcome. Ms. Figueroa's affirmative statements that she missed his lips, struggled to not think about kissing his face, and specifically invited him to initiate texting and to find a day/time for their meeting suggest she was not only a willing participant, but that she initiated these contacts with Mr. Fletcher. For these reasons, the allegation that she was "shocked and confused, but [felt] powerless to say no..." is provably **false**. Her claims that she was "lured" her to his hotel and "convinced" to visit are also overtly false misrepresentations.

Alleged Incident #2: MTS Executive Committee Meeting on June 9, 2022

Ms. Figueroa next falsely alleges that after the May 12, 2022 encounter at Mr. Fletcher's hotel, he told her, on June 9, 2022, to meet him in a conference room after an MTS Executive Committee meeting because "[he had] five minutes." (SAC ¶ 37). In the conference room, she claims that he kissed and touched Ms. Figueroa and that she "was not comfortable having this type of encounter with him, especially at MTS headquarters, while coworkers and managers were immediately outside the door." (Id.). Ms. Figueroa alleges that she only entered the room because she was "intimidated by the dynamic Mr. Fletcher had created" and because she "feared that she would lose her job if anyone found out that she was being pursued sexually by the senior most ranking official at MTS...its Board Chair." (SAC ¶ 36). Lastly, she also claims she left the room after supposedly be sexually assaulted because she "felt shocked and uncomfortable."




We now know from Ms. Figueroa's Instagram communications and discovery responses that each of these allegations are false in every respect.³ The totality of Ms. Figueroa's communications with Mr. Fletcher on June 9, 2022 (as well as the days immediately before) demonstrate that the she intentionally concealed the true nature of their encounter that day. To clarify, on June 3, 2022, Ms. Figueroa texted Mr. Fletcher "<u>uhmmm yummm</u>" after learning that he had grown a near-full beard. In subsequent texts, they mutually expressed that they would like to meet-up again in-person, and that they fondly remembered their time in the stairwell on May 12, 2022. She was "hopeful" to meet him again and stated "awwww I'd like that..." regarding another in-person interaction:




³ Ms. Figueroa has already admitted, under oath, that Mr. Fletcher was not her employer or direct supervisor. He had no authority to hire her, pay her salary, determine her work schedule, or promote or terminate her employment. She has also conceded that "her job required very little, if any, direct interaction" with him. (SAC ¶16). She knew these facts prior to filing her lawsuit in March 2023 but still manufactured her false allegations as part of her concerted effort to assert more baseless claims against him. Thus, her insinuation that Mr. Fletcher was "intimidating" her by threating an adverse employment action is objectively unreasonable, from the outset.

<u>It was within this context that Mr. Fletcher texted Ms. Figueroa "hi" on June 9, 2022</u>. In response, and contrary to the allegations in Paragraph 37 of the SAC, it was actually *Ms. Figueroa* who told Mr. Fletcher to "<u>Try!</u>" to stay after an MTS Executive Committee meeting. She also told him that she would "<u>come by</u>" to see him "<u>if [he went] in the room on the side.</u>" Mr. Fletcher did as Ms. Figueroa instructed and went into the side conference room. *She* then specifically confirmed that "<u>everyone was gone</u>" prior to entering the room, in <u>direct contradiction</u> to the false narrative that he initiated. Put another way, Ms. Figueroa *wanted* privacy so that she could meet with Mr. Fletcher, contrary to her claim that she was not "comfortable having this type of encounter with him, especially at MTS headquarters, while coworkers and managers were immediately outside the door." (SAC ¶37).



Ms. Figueroa was in the conference room with Mr. Fletcher on June 9, 2023 for <u>no more</u> than three minutes. Immediately after the encounter, she **never** expressed any discomfort or unease about their meeting. **Instead, she texted Mr. Fletcher** <u>a kissing emoji</u> and stated it

was "nice to see [him]". She also stated that her birthday was already off to a good start as a result of their meet-up:





Much like her behavior after seeing Mr. Fletcher at his hotel on May 12, 2022, Ms. Figueroa's conduct <u>in the days after</u> the June 9th MTS Executive Committee meeting demonstrates that she not only consented to her ongoing interactions with him, but was a willing participate in those interactions. For instance, on June 16, 2022, **despite alleging that Mr. Fletcher sexually assaulted her just one-week prior**, she jokingly chastised him for <u>failing to wish her a happy birthday</u> before agreeing that he could "<u>make it up to [her]</u>." She also flirtatiously invited him to "<u>demonstrate anythinggggg</u>" for her. If this was not enough, she repeatedly brought him gifts and complained when he didn't reciprocate. For instance, she asked whether Mr. Fletcher brought her souvenirs from a recent trip:



The following day, on July 17, 2022, Ms. Figueroa and Mr. Fletcher exchanged flirtatious <u>kissing and heart emojis</u>. Two weeks later, on July 4, 2022, she wished him (unsolicited) a "<u>great</u> [July] 4th." He did not respond:



To recap, the communications demonstrate – beyond any doubt – that Ms. Figueroa was not assaulted by Mr. Fletcher on June 9, 2022, nor at any other time. She called him "<u>vum[my]</u>" and expressed an interest in meeting privately with him in the days immediately preceding the Committee meeting. She then told him to "<u>Try!</u>" to stay after the meeting; <u>instructed him</u> which conference room to meet her in; ensured that "<u>everyone [was] gone</u>" before entering the room; and remained in the conference room for <u>no more than three minutes</u>. After supposedly being "sexually assaulted multiple times", Ms. Figueroa <u>never</u> expressed any discomfort and instead texted Mr. Fletcher that her birthday was already "<u>a good one</u>" *immediately* after leaving the room. She accompanied this message with a <u>kissing emoji</u>. In the month after the purported "assault", she suggestively invited Mr. Fletcher to "<u>demonstrate anythingggg</u>" for her; expressed disappointment when <u>he did not wish her a happy birthday</u>; asked if he brought her any <u>gifts</u> from a recent trip; and wished him a <u>happy Fourth of July</u>.

Based upon Ms. Figueroa's communications with Mr. Fletcher, it could not be clearer that Ms. Figueroa and her counsel manufactured a **false and egregious** narrative that Ms. Figueroa was sexually assaulted by Mr. Fletcher in a conference room on June 9, 2022, after an MTS Executive Committee meeting.

Alleged Incident #3: MTS Executive Committee Meeting on December 1, 2022

In addition to the hotel encounter on May 12, 2022 and the conference room encounter on June 9, 2022, Ms. Figueroa also **falsely** alleged that Mr. Fletcher sexually assaulted Ms. Figueroa on December 1, 2022 after an MTS Executive Committee meeting. She claims she "carried an unremitting sense of anxiety" and "felt trapped" after her pervious encounters with Mr. Fletcher. Although she supposedly wanted Mr. Fletcher to stop "pursuing her sexually," she suggests in the SAC (using out-of-context communications) that he asked her to "come say hi"

after an MTS event. (SAC \P 41, 45). When Ms. Figueroa arrived in the room, he purportedly kissed and touched her, causing her to be "shocked, scared, and "humiliated." (SAC \P 47):



Each of the allegations relating to this December 1, 2022 encounter are **provably false**. Ms. Figueroa again manufactured a fictitious narrative designed to inflame the public against Mr. Fletcher and portray Ms. Figueroa as a "shocked, scared, and humiliated" victim. However, it is clear that *she* eagerly and aggressively pursued Mr. Fletcher's companionship for several months. For example, contrary to the fictitious story in the SAC, Mr. Fletcher only texted Ms. Figueroa to "come say hi" *after* she flirtatiously told him that she wanted to "<u>say something inappropriate</u>" to him. Worse yet, *she* also instructed him to tell *her* "<u>when [he was] alone</u>" before she freely entered the conference room. Ms. Figueroa intentionally omitted these unfavorable and inconvenient details:

True to form, Ms. Figueroa further omitted *hundreds* of other messages from the SAC that were transmitted *after* the December 1st meeting, and which show her ongoing interest and attraction. For example, **just four days after supposedly being sexually assaulted by Mr. Fletcher**, she offered to think about him while in bed and repeatedly stated that she wished he



Approximately ten minutes later during this same conversation, Ms. Figueroa continued to flirt with Mr. Fletcher and make sexually suggestive comments to him. First, she offered to "keep [him] company" while he drove home from the airport after returning from a trip to Sacramento.xviii Then, she texted – for a second time – that she "wished [he was with her]," along with a red lips emoji. She also sent a subsequent text calling him a "bad boy." Ms. Figueroa intentionally removed these segments of their converstaion. (Compare to SAC ¶ 49).: (December 5, 2022, 11:21 PM. See Pltf Comm 00030)

After failing to coordinate another in-person meeting, Ms. Figueroa and Mr. Fletcher ended their conversation for the night by telling each other that they would be dreaming of each other. For her part, Ms. Figueroa sent him another red lips emoji and called him "king" and a "delicious little thing" in Spanish. Again, this conversation occurred just four days after she claimed to have been sexual assaulted:

On December 8, 2022, just one week after she was purportedly assaulted, Ms. Figueroa again expressed her consent when she sent Mr. Fletcher a message in which she called him "handsome", in response to him stating "hi there." She then stated in Spanish "ganas de <u>comerte</u>", meaning that she "wanted to eat him" – an overt and highly sexualized reference to oral sex. Notably, she seemingly deleted this crude comment from her screen-recorded messages, demonstrating that she *knew* its extremely sexual and salacious nature. Ms. Figueroa also confirmed the comment accurately reflected her "<u>real</u>" feelings. For these reasons, and like her other communication, this message is in stark contrast to her allegations that she felt "an inescapable blanket of shame, distrust, and entrapment as she realized there was no way to avoid the emotional prison Fletcher created for her at MTS." (SAC ¶ 51).:

After Ms. Figueroa's "ganas de comerte" comment, Mr. Fletcher stopped responding. Nevertheless, at the end of the month on December 31, 2022, Ms. Figueroa sent Mr. Fletcher an unsolicited Happy Birthday wish. <u>In response</u>, he wished her a Happy New Year. The Second Amended Complaint intentionally omitted the key detail that <u>Ms. Figueroa initated</u> the communication on this day. <u>Compare</u>:

To recap, **Mr. Fletcher did not sexually assault Ms. Figueroa at the MTS Executive Committee meeting on December 1, 2022, nor at any other time or event, and there is no evidence suggesting anything to the contrary**. Mr. Figueroa's own communications demonstrate that on December 1, 2022, she and Mr. Fletcher had a brief physical encounter in a conference room that was voluntarily in all respects, following a months-long pursuit by Ms. Figueroa (detailed further below). The encounter amounted to nothing more than a brief kiss and some light touching, and did *not* include any sexual intercourse or oral sex. Ms. Figueroa's discovery responses support these facts. For these reasons, it is clear that Ms. Figueroa not only consented to the December 1st interaction, but also that she continued to eagerly pursue Mr. Fletcher in the month that followed. She escalated her flirting and suggested, in colloquial Spanish, that she wanted to perform oral sex. Her claims that she "went out of her way to avoid [Mr. Fletcher]" and that she was victimized by him on December 1, 2022 are demonstrably false. (SAC ¶ 51).

Alleged "Stalking": Ms. Figueroa Pursued Mr. Fletcher Throughout 2022

In addition to the above, Ms. Figueroa's communications in the days, weeks, and months *before* the December 1st MTS meeting further demonstrate that *she* escalated, desired, and initiated their interactions. For example, on August 4, 2022, Ms. Figueroa jokingly called Mr. Fletcher a "bad boy"; stated that she enjoyed briefly seeing him that day; and commented that his dog was a "cutie" who "takes after the dad":

That same day on August 4, <u>she also specifically expressed interest in seeing Mr. Fletcher</u> again in a less crowded setting, foreshadowing their future December 1st meeting:

On September 15, 2022, Ms. Figueroa sent Mr. Fletcher an unsolicited compliment about his glasses, accompanied by a wink-face emoji:

On October 20, 2022, she used Spanish to call him "Papasito", before using Spanish to call him "<u>rich little thing</u>" or "<u>delicious little thing</u>" (i.e. "cosita rica"). In the same text, *she* also requested that he erase their chat:



Two days later, in the afternoon of October 22, 2022, Ms. Figueroa sarcastically implied that Mr. Fletcher was a "cutie" while jokingly referencing a picture of a dog:





On November 2, 2022, Ms. Figueroa called Mr. Fletcher "campeon!" (translating to "champion!"). On November 9, 2022, she called him "Superman!!":

(November 2, 2022, 9:12 AM. See Pltf Comm_00041)




On November 10, 2022, <u>exactly three weeks before the December 1st MTS Executive</u> <u>Committee meeting</u>, Ms. Figueroa again <u>affirmatively</u> sought an in-person encounter with Mr. Fletcher. This time, she flirtatiously asked him when she could "visit prof Fletch?"⁴ She was so eager that she made him "<u>promise</u>" to find a time to meet privately before classes ended for the semester. She also stated that she was looking forward to seeing him and accompanied her message with a <u>kissing emoji</u>. Indeed, contrary to her claims that she felt "trapped" and was carrying an "unremitting sense of anxiety" after the June 9th encounter, Ms. Figueroa continued to pursue him in the days immediately preceding their December 1st meeting. Her pursuit also included <u>wishing him a "Happy Veteran's Day:</u>)" and stating that she hoped to see him be the end of the day. Again, these messages foreshadow their imminent meeting on December 1st:



(November 10, 2022, 10:42 AM. See Pltf Comm_00039)

Throughout 2022, Ms. Figueroa made numerous other statements and communications demonstrating her consent and willingness to interact with Mr. Fletcher. For example, she made movie suggestions to him and followed up – unsolicited – several days letter to see if he enjoyed her recommendation.^{xix} She inquired about his children, including his son's birthday.^{xx} She communicated disappointment when Mr. Fletcher indicated that he would be moving away from downtown.^{xxi} She volunteered to him, unsolicited, that she was at his speech.^{xxii} She also frequently texted flirtatious emojis, including kissing/lips emojis.^{xxiii} Notably, the entire narrative that Mr. Fletcher "stalked" Ms. Figueroa on social media is **false**, especially considering that <u>she</u> "started an [Instagram] chat" with him on August 24, 2021:



3. Ms. Figueroa's Allegations Are Subject to a Motion to Strike, Given That They Are False, Irrelevant, and/or Immaterial

Ms. Figueroa's lawsuit is independently unsustainable and subject to dismissal because Mr. Fletcher was not her employer or direct supervisor. She has admitted this fact under oath in her responses to Mr. Fletcher's Requests for Admission, Set One.^{xxiv} Consequently, it is impossible for her to ever establish liability against him on her FEHA and Intentional Interference causes of action. As we have repeatedly explained, Mr. Fletcher did not hire Ms. Figueroa, pay

her salary, determine her work schedule, or have any authority to promote or terminate her employment with Defendant San Diego Metropolitan Transit System. She has also conceded that "her job required very little, if any, direct interaction" with Mr. Fletcher. (Second Amended Complaint ¶16). Given that he was not involved in her employment or termination in any way, Ms. Figueroa's claim in her original Complaint that MTS attempted to coerce her into signing a severance agreement that specifically released Mr. Fletcher from legal liability in exchange for a \$10,000 payment was always demonstrably untrue. These facts are dispositive as to her employment law causes of action, and the fact that she continues to maintain such a baseless claim is further evidence of bad faith. Consequently, the first, fifth, sixth, and nineth causes of action are subject to demurrer and/or motion to strike and must be dismissed in their entirety.

Ms. Figueroa's personnel file conclusively demonstrates that Mr. Fletcher never exerted any influence over her employment, nor did he play any part in her termination. Indeed, she was terminated by MTS as a result of her own poor, inconsistent performance.⁵ She received repeated warnings in-person, via email, and in formal performance evaluations, regarding her performance deficiencies. Her supervisor also observed that it had "become clear that [Ms. Figueroa's] inconsistent performance will not change, and management of [her] department no longer believed that [she] meet the job's minimum performance standards." Further, in all four of her performance reviews, Ms. Figueroa was warned that her written communication and project management skills needed improvement. She was given specific guidance on how to improve and what would constitute adequate performance. Despite this, she failed to improve her time management problems; she missed important deadlines; and she turned in work that needed to be heavily edited or reworked. In short, the evidence is overwhelming that MTS terminated her employment without any input or foreknowledge from Mr. Fletcher.

Ms. Figueroa was a poorly performing employee who was terminated after being granted multiple opportunities to improve. Her termination was not linked to Mr. Fletcher, nor was she even in an employment relationship with him. Consequently, all of her employment law causes of action against Mr. Fletcher are unsustainable and must be dismissed in their entirety.

Additionally, we have reviewed Ms. Figueroa's Second Amended Complaint and are disappointed – though unsurprised – that she continues to include the same false, irrelevant, and immaterial allegations relating to Mr. Fletcher's wife and privileged communications. Given that we have repeatedly identified these specific defects, please accept this correspondence as our final good faith effort to meet and confer, pursuant to Code of Civil Procedure sections 430.41 and 435.5, regarding Mr. Fletcher's prospective demurrer and/or motion to strike. All references to Mr. Fletcher's wife must be removed, given that she is not a party to this action and because there are no allegations that she participated in – or was even aware of – any conduct described in the SAC. Indeed, the only reason Plaintiff specifically mentions Mr. Fletcher's wife was to cause *her* embarrassment and attempt to disrupt *her* career. Doing so adds nothing to the legal claims and is improper. All paragraphs referencing confidential, pre-litigation settlement communications must also be removed, given that the communications are both privileged and inadmissible at trial. For this reason, Paragraphs 17, 26, 58, 59, 60, 61, 62, 63, 64, 65, 66, and 67 are irrelevant

and immaterial to all of Plaintiff's claims and must be voluntarily stricken. Paragraph 42 of the SAC is also false, irrelevant and immaterial to all of Plaintiff's claims and must be voluntarily stricken. Finally, each and every false allegation described above is similarly subject to our anticipated motion to strike, pursuant to Cal. Code Civ. Proc. Section 436(a) and (b).

4. In light of the Evidence, Sanctions May Be Awarded Against Ms. Figueroa and The Pride Law Firm

California's Rules of Professional Conduct provide clear instruction and guidance when it comes to attorney misconduct. <u>Rule 3.1(a)(1)</u> states that a lawyer shall not bring *or continue* an action, or assert a position in litigation, without probable cause or for the purpose of harassing or maliciously injuring any person. Similarly, <u>Rule 3.3(a)(1)</u> provides that a lawyer shall not "knowingly make a false statement of fact or law to the tribunal or fail to correct a false statement of material fact or law previously made to the tribunal by the lawyer." Importantly, <u>Rule 8.3(a)</u> imposes a new *obligation* to report misconduct arising from dishonest behavior, or from reckless or intentional misrepresentations. To this end, the State Bar has identified false statements made by an attorney *when opposing discovery motions* as one, specific scenario that raises a substantial question as to an attorney's honesty and is among the list of conduct enumerated for mandatory reporting under rule 8.3.

Ms. Figueroa and Her Attorneys Have Always Known This Case is Without Merit

Here, Ms. Figueroa and her team of attorneys were aware – at all relevant times – that she was a consensual participant in her encounters with Mr. Fletcher. *She* escalated the nature of their interactions and sexualized their written communications. She also lied to Mr. Fletcher that she was deleting their communications in real time, while simultaneously insisting that he delete his side of the chats from his phone, in effort to ensure that she was the sole possessor of the key, exonerating evidence.^{XXV} Despite this, and although Ms. Figueroa possessed the entirety of her communications prior to the filing of this lawsuit, Mr. Schumacher and/or The Pride Law Firm repeatedly published misleading and out-of-context communications in multiple amended complaints, seemingly for the purpose of harassing Mr. Fletcher and his family to obtain a seven-figure settlement. Such conduct is improper and represents a bad faith filing and maintenance of this groundless action.

Ms. Figueroa's Attorneys' Attempted To Withhold Exonerating Evidence

In addition to Ms. Figueroa's false allegations in her multiple complaints, The Pride Law Firm's written opposition and oral arguments opposing Mr. Fletcher's discovery motions have also been littered with intentionally false statements, including overt misrepresentations to the court that exonerating documents were previously produced in discovery, when they had not. Their conduct has already resulted in sanctions, and also directly caused Mr. Fletcher personal damage by allowing Ms. Figueroa's self-serving – and false – narrative to be continually reported on by those in the media. Each of these actions are grossly unprofessional and in clear violation of Rules 3.1 and 3.3.

For these reasons, Ms. Figueroa, Mr. Schumacher, Mr. Freire-Avina, Ms. Jessica Pride, and Mr. Dante Pride have maliciously and repeatedly engaged in an ongoing effort to destroy Mr.

Fletcher's reputation, career, family, and finances. They have made knowingly false and deceptive statements, publicly and to the court, in an obvious attempt to obtain a quick, undeserved, and coercive financial settlement. Their misrepresentations have been repeatedly published millions of times in the media. <u>Such conduct is grossly improper and demonstrates</u> **that this lawsuit was filed, and is continuing, in bad faith and with malicious intention**. Under California law, the court may award attorneys' fees to the defendant where a claim is pursued beyond the point where the plaintiff no longer believes the case has merit. (See, e.g., *Yield Dynamics, Inc. v. TEA Systems Corp.* (2007) 154 Cal.App.4th 547, 579, fn. 20; *Gemini Aluminum Corp. v. California Custom Shapes, Inc.* (2005) 95 Cal.App.4th 1249, 1264). Similarly, sanctions may be awarded against a plaintiff for the bad faith filing <u>or maintenance</u> of a groundless action. (See *Zamos v. Stroud* (2004) 32 Cal.4th 958, 970 ("attorney may be liable for malicious prosecution for continuing to prosecute a lawsuit discovered to lack probable cause".)) Mr. Fletcher intends to pursue such relief in the event this action is not immediately dismissed.

Ms. Figueroa and her attorneys' behavior in this matter has already been sanctionable and likely represents serious abuses to California's well-established rules of procedure and professional conduct. The evidence is overwhelming – and unambiguous – that Mr. Fletcher's interactions with Ms. Figueroa were always consensual and that no sexual battery/assault ever occurred. Ms. Figueroa's wrongful withholding of relevant documents and information while pushing a knowingly false narrative, further suggests that she knew that her case was unsustainable if her communications were ever disclosed. Her behavior also suggests that she was attempting to coerce Mr. Fletcher into acquiescing to her settlement demands. As a result, this action must be dismissed in its entirety. Otherwise, we have no choice but to explore all avenues to secure a dismissal and recover our legal fees, as well as damages for the significant harm caused Mr. Fletcher.

5. Conclusion

Mr. Fletcher has always maintained that he never sexually battered or assaulted Ms. Figueroa, nor did he engage in any other legal wrongdoing. He has always vehemently disputed her salacious claims and described her allegations as categorically false.^{xxvi} Nevertheless, he has also always acknowledged that he made a personal mistake in engaging in consensual interactions with someone outside of his marriage. He acknowledged that he violated the trust and loyalty of his wife and set a poor example for his children. Critically, however, Mr. Fletcher's acknowledgment of a personal mistake in engaging in consensual encounters with Ms. Figueroa does not give rise to any legal liability.

For all of the reasons set forth above, Ms. Figueroa, Mr. Schumacher, and The Pride Law Firm have not participated in this lawsuit in good faith. Evidence of a consensual relationship was deliberately omitted from Ms. Figueroa's initial Complaint, her First Amended Complaint, and now her Second Amended Complaint. Statements were made to the media and in other public forums that furthered the promotion of a sensationalized narrative regarding the false claims for sexual assault and battery. Ms. Figueroa and The Pride Law Firm also engaged in a campaign to obstruct and prevent disclosure of critical communications that support Mr. Fletcher's defense to these outrageous and unsubstantiated claims. This entire lawsuit is without merit and must be dismissed in its entirety.

While Mr. Fletcher has always maintained that Ms. Figueroa's claims were without any merit, the production of evidence since she filed her Complaint demonstrates that Ms. Figueroa's and Mr. Fletcher's interactions were consensual at all times. <u>Therefore, we demand that this</u> <u>lawsuit be dismissed in its entirety no later than January 8, 2023</u>. We will be accompanying this letter with a C.C.P section 998 Offer that will allow you to dismiss this case in its entirety in exchange for a waiver of our costs. We strongly urge you to accept this offer before Mr. Fletcher incurs even more expenses, particularly those anticipated from a future trial. If Ms. Figueroa declines, we will be forced to pursue all available claims and forms of recovery against her, given that she needlessly continues to inflict emotional and economic damage on Mr. Fletcher.







Hello,

I wanted to share this with you. I've seen some criticism about the Youth Opportunity Pass (YOP) on social media (not too much, but some), and although it might not come from transit riders, the comments aren't coming from students. Today, I scanned through our 2020 Essay Contest submissions where we asked students in SD to pick their top 3 Elevate SD projects and write a persuasive essay.

Many of them picked YOP, so I pulled these excerpts to see what they had to say. I was quite impressed. We might use them for a blog or post here at MTS....however, I thought I'd share them with you too because I feel like negativity can sometimes drown the real positive impact this is having on so many families. I know you already know that, but I hope you enjoy reading these too:

Excerpts from the 2020 MTS Essay contest, where we asked kids to choose their top 3 Elevate SD projects. Here are some who chose the Youth Opportunity Pass as one of them:

"As a student, I have heard many of my classmates ask around for change to get on the bus. Some of them have to walk more than 30 minutes back home if they don't have enough fare on them and others have terrible attendance because they have trouble even arriving to school on time with how far they live. The Youth Opportunity Passes would be incredibly beneficial to many kids and young adults that are still in school. Not needing to worry about how they would get to school on time, they wouldn't have to worry about walking alone in the dark, this project would help immensely to the student population. There are students who cross the border every day to get to school and to go back home. Students whose parents can't cross or drive them back would especially benefit from this program because it would decrease their, and their parent's, worries on getting back home safely." Hoover High, Grade 10

"MTS should implement this program to ensure children have wider access to environmentally-friendly travel options" – West view high, Grade 9

"Affordability and inequity run hand in hand; while some San Diegans don't need to think twice about money, many are faced with financial hurdles that affect their daily lives, and daily activities such as transportation. These programs aid people who may have to sacrifice a meal in order to ride the bus home, or who are physically unable to work enough to afford transportation of any other kind"- University city high, grade 12

"YOP would increase access to so many educational opportunities for the San Diego youth. For the kids who live in low income families this would provide financial relief for their families. This program would help MTS in the long run because it will help create lifelong transit riders. Creating roughly 2.3 million more trips a year by providing this new program is implemented in San Diego (elevate2020sd.com, 2019). By helping approximately 600,000 students, this program would be a homerun! - Grossmont High, Grade 11

"For the millions of working class San Diegans that live paycheck to paycheck, public transportation has become the sole difference between holding a job and having to fill out unemployment forms. I speak from experience as a child of a single parent household, it was carpooling and trolley lines that kept a roof over my head and food on the table. There's no doubt that hundreds if not thousands of other families here in San Diego share my experiences when it comes to the vitality of public transport."- Eastlake High, Grade 12

"Low income families would have the tranquility of knowing that their children have a way of getting home while they are working to earn a living. Students would be able to reach their fullest academic capabilities and utilize all the educational opportunities available to them because they wouldn't have to worry about not having enough money to be able to transport themselves from one place to another. It's a proposal that benefits the individuals in society that need it the most and who at times are unable to ask for help."- San Marcos High School, 12

"This would help children get into the habit of using transit systems, and that in the future, they can save more and direct those funds that they would in turn use on a car, towards funding their way through college, attaining better career opportunities. This potentially opens new doors for low-income families." – Grossmont High, grade 10

"The pass would open a door to new educational and career opportunities for San Diego minors. This will create a fair rate of return for the public, as many more people will attain higher education and higher paying jobs, collectively reducing crime rates and opening more doors for people to invest in San Diego." Grossmont High, 9 grade

"In a household that is already struggling monetarily, having to pay an extra \$2.50 every time a household member has to travel could become debilitating and nearly impossible. The Youth Opportunity Passes, which would provide free transport to youth 18 and under, could lessen the burden of sending teenagers to school, work, or any other recreational activity that cannot be easily accessed. Some researchers may argue that the Youth Opportunity Passes will be a waste of money because only about 6.3% of San Diego public transportation riders are 18 and under, therefore it won't be helping a large portion of people. However, according to San Diego Youth Services, youth homelessness is on the rise in San Diego with an increase of 35% in 2018. (sdyouthservices.org) Homeless youth could use free transportation to get to schools, job interviews, or leave dangerous situations. Youth Opportunity Passes could combat financial hardship in San Diego families and homelessness in San Diego communities"- Valhalla High School, 12 grade

"When my dad suddenly died nearly two years ago, my mom became financially responsible for three teenagers by herself. All parents and teens will benefit from this new program". Valley Center High School, 12

"Some people may see this as unnecessary because they think young people use public transportation mainly to go out and have fun, implying they should pay for the normal price but that is not the case. This is an eminently significant issue because a lot of students that don't have cars or parents that can drive them depend on these buses to get to and from school every day. Most of them live far away too, and simply stay for the better classes and teachers." – Castle Park High, 11

"In many high schools, 1st-period attendance is very low because many students have to wait on others for car rides or walk to school, causing them to repeatedly be tardy. The harsh reality is that many students don't have the funds to purchase a bus pass, or pay the amount of the one-way fare; especially in highly populated urban areas where the struggles of poverty continue to persist. Few programs exist to support the students obtaining access to public transportation. These programs should either be expanded or highly advertised to ensure that students are knowledgeable about these opportunities. If an act in the Elevate SD 2020 Plan that supported these types of students was enacted, then the City of San Diego would have a brighter future full of well educated, brilliant kids, who could help to further change based on their own

RE: Termination of Employment

Dear Ms. Figueroa:

The purpose of this communication is to inform you that, effective today, your employment is terminated for the reasons set forth in this letter.

On June 26, 2019, MTS hired you as a Marketing Specialist. On April 19, 2022, as part of a departmental restructure, your title was changed to Public Relations Specialist. During your tenure at MTS, your overall performance has been inconsistent. You perform well in certain aspects of your job, like media relations, but poorly in others such as writing, follow up, meeting deadlines, and prioritizing your work. Your shortcomings require that your supervisors spend a substantial amount of time double checking your work, correcting your errors, and directly managing your assignments.

You have received repeated warnings regarding your performance deficiencies, in person, via email, and in formal performance evaluations. There have been brief periods of improvement that provided hope that you could meet the overall demands of the position. However, over 3.5 years later, it has become clear that your inconsistent performance will not change, and management of your department no longer believe that you meet the job's minimum performance standards.

In all four (4) of your previous performance reviews, you were warned to varying degrees that your written communication and project management skills needed improvement. You were given specific guidance on how to improve and what would constitute adequate performance. For example, you were directed to take project management courses to improve your time management skills and allow you to meet deadlines, but you never completed.

In your most recent performance review, which was given to you in writing in August 2022 and you signed for on November 14, 2022, management went into significant detail about your performance issues during that review period, and admonished you that your job was in jeopardy. In the Performance Summary portion on pages 11 and 12, they concluded with the following admonishment:

We believe that Grecia has the potential to be a high performer, as her 'Areas of

Strengths' are excellent, and want to see her succeed in her new position. *However, immediate and sustained improvement in the 'Areas of Improvement' section is necessary to maintain employment.* Due to ongoing performance issues, we are recommending a 3% merit increase. However, Mark and I will formally re-review your performance in 3 to 6 months. If there is significant improvement, we will recommend an additional 3% increase. (Emphasis added)

Mr. Olson and Ms. Bishop have continued to evaluate your work since your performance review, and you continue to exhibit the same deficiencies. Specifically, you continue to have time management problems, miss important deadlines, and turn in work that needs to be heavily edited or reworked.

Some recent examples are:

- a. Intelligent Transport Article:
 - Mr. Olson forwarded an inquiry for a guest article in Intelligent Transport to you on October 18, 2022 and asked you to secure a spot. On November 10, seeing no response, Mr. Olson followed up. You claimed to not have seen the original email, and subsequently reached out to secure a December 5 deadline.
 - On December 2, Mr. Olson asked Ms. Bishop to reach out for a status update. You confirmed you did secure the spot, but that no progress had been made to outline/develop content; at that time the deadline was extended one week to December 12.
 - After no content was provided by Friday, December 9, and you called out of work, Ms. Bishop requested the draft article/current outline several times as the Monday deadline was impending. When staff finally received the copy at 4:30 p.m. December 9, only 40 – 50% of the word count requirement had been met.
 - The final article was not submitted until December 16, 11 days after the first deadline and four days after the second deadline.
- b. Progressive Railroading Article:
 - A query from Progressive Railroading came in November 28, 2022 with a deadline of December 16, 2022. In an email to both Rail Operations and you on the same day, Mr. Olson asked you to gather the responses and make a submission to the reporter.
 - Rail Operations staff provided their responses on November 29. However, no
 progress was made in finalizing the content until Mr. Olson reached out to you to
 ask about the status on December 12. You responded that you thought Mr.
 Olson had already handled it, even though Mr. Olson had assigned the project to
 you.
 - Mr. Olson provided final edits of the content to you on the morning of December 15.
 - On December 16 (the deadline), the response was not submitted. Mr. Olson had to send a reminder to you on Monday, December 19 to ask you to submit the responses.

- c. MTS Connections:
 - Discussions for the first edition of the MTS Connections newsletter began in July 2022, and the original distribution date was set for mid-September. Upon Ms. Bishop returning from vacation in early August, the deadline for the newsletter had been pushed back two weeks by you, seemingly arbitrarily, as no reason was given for the change. There were not clear (or possibly, realistic) timelines throughout the process, and ultimately the edition did not get distributed until mid-November.
 - Given the challenges and delays in publishing the first edition that you managed, the next edition of MTS Connections was discussed with you during check-in meetings on December 1 and December 7. Ms. Bishop requested that you create a project timeline by working backward from a distribution deadline of mid-February. You were asked to provide topics by December 16; as of that day, nothing had been provided and Ms. Bishop followed up to ask you for them by December 20 at the latest.
 - Topics were not provided by you until after staff had left the office (early for the holiday weekend) on December 23, 2022 and most of the content ideas had to be reworked entirely by Mr. Olson and Ms. Bishop.
 - Story deadlines for staff were due on January 25. As of January 26, you and two other contributing writers had not written your assignments (about half the edition's content), and the distribution is expected to be delayed from the initial goal by a minimum of two weeks.
- d. Laptop Scholarship Essay Contest:
 - In initial conversations with Ms. Bishop, and in the performance review given to you in August 2022, one of your performance metrics was to "Successfully execute the 2022 Laptop Scholarship contest in fall 2022, with final submission date no later than November 4, 2022." However, when it became clear that the timeline would not be met, Ms. Bishop adjusted the date to be "November 2022" in an effort to try and help you achieve the goal.
 - On August 23, 2022, you reported to have had essay topics that you would send "in a few days", but the prompts were not submitted until September 16.
 - In an email response on September 22, Mr. Olson stated he wanted the contest's end date to be November 18 before the Thanksgiving holiday (with an earlier launch/submission date), but you pushed for and selected the November 25 deadline.
- e. News Releases:
 - In general, timelines that were outlined in the media management document you created were not consistently met (i.e., submitting draft news releases to Mr. Olson and/or Ms. Bishop with little time for review), putting pressure on other staff and departments to turn around content the same day or next day in many cases.

- Several special event news releases that had been discussed during check-in meetings with Ms. Bishop were never executed (e.g., Elton John, December Nights).
- -
- f. You were assigned to complete project management courses in three annual reviews (2020, 2021, 2022). To-date, those have not been completed.
- g. You continued to come to work late after repeated warnings.

Mr. Olson and Ms. Bishop agree that you perform well in certain areas, like media relations. However, they have lost confidence in your ability to perform adequately in all aspects of your job, because you have been given ample opportunity to improve. In short, MTS has higher expectations for this position and can no longer tolerate the additional workload placed on others by your errors and inability to meet deadlines.

MTS does not believe that your shortcomings were purposeful or malicious, so the Agency attempted to offer you severance pay via a Separation Agreement to ease your transition to other employment. On Monday, February 6, 2023, I explained that MTS had decided to part ways with you, and I explained the terms of the proposed the Separation Agreement. Since February 6, despite repeated requests, you have been unwilling to engage in meaningful communications regarding the Separation Agreement.

When you accepted employment in June of 2019, you signed an offer letter agreeing that your employment is at will, and that you or MTS could end the employment relationship at any time for any reason or no reason. MTS has decided to exercise this option and terminate your employment for the reasons set forth in this letter.

CUSSD further informed Plaintiff that any amendments to include claims of discrimination would be futile as CUSSD is not an employer subject to FEHA and that Plaintiff failed to timely file an administrative charge with the EEOC. Plaintiff did not respond. Attached as **Exhibit 7** is a true and correct copy of Ms. Ricardo's July 12, 2023 correspondence to Plaintiff's counsel copying me.

9. On July 14, 2023, CUSSD served Plaintiff and her counsel a Motion for Sanctions
Pursuant to Section C.C.P. § 128.7 for filing her initial complaint, which included Plaintiff's
personnel file and payroll records as exhibits.

10. 21 On July 27, 2023, the Parties met and conferred to discuss the deficiencies of 22 Plaintiff's Complaint. Ms. Ricardo immediately informed me of her conversation with Plaintiff's 23 counsel. Plaintiff's counsel acknowledged that FEHA did not apply to CUSSD. However, Plaintiff's counsel contended that Plaintiff could proceed with her claims under Title VII despite 24 25 the untimely filing and contest any statute of limitations arguments through motion practice. Plaintiff's counsel represented that Plaintiff would amend her Complaint to remedy the deficiencies 26 27 of her four causes of action. 2	11. Plaintiff requested an additional two weeks to amend their complaint, essentially
3	extending their safe harbor period to August 18, 2023. CUSSD agreed to permit Plaintiff to file her
4	FAC by August 18, 2023. A true and correct copy of Senior Counsel Kathryn B. Fox and Ms.
5	Ricardo's correspondence with opposing counsel copying me is attached hereto as Exhibit 9.

6 12. On August 18, 2023, Plaintiff filed her First Amended Complaint ("FAC"), which
7 alleged the same four causes of action and differed only slightly from the original complaint.

8 13. On August 28, 2023, CUSSD served its Motion for Sanctions pursuant to Code of
9 Civil Procedure § 128.7 (the "Motion for Sanctions") on Plaintiff. Plaintiff did not withdraw or
10 seek to amend her FAC during the 21-day safe harbor period.

11 14. On September 21, 2023, CUSSD filed its Motion for Sanctions. In Opposition,
12 Plaintiff did not submit her own declaration to support her claims.

13 15. On September 14, 2023, Plaintiff served her first set of Form Interrogatories14 General, Form Interrogatories-Employment, Special Interrogatories, and Requests for Production
15 on CUSSD. On October 17, 2023, CUSSD provided its responses to Plaintiff's discovery requests.
16 0n October 19, 2023, this Court issued a tentative order granting CUSSD's Motion

17 for sanctions.

17. On October 20, 2023, this Court heard CUSSD's Motion for Sanctions. At the
hearing, Plaintiff's counsel represented that Plaintiff could allege discrimination claims under Title
VII or California Business and Professions Code § 17200 *et seq*. The Court took the parties'
arguments under submission.

18. Following the hearing, CUSSD and Plaintiff met and conferred telephonically where
CUSSD again requested Plaintiff to withdraw her Complaint and reiterated its position as to why
Plaintiff's claims are frivolous and that she suffered no damages. Plaintiff's counsel indicated "We
don't care if we get damages. We are going to get publicity."

26 19. On November 21, 2023, a month after the hearing, This Court issued its order
27 granting the Motion for Sanctions, awarding sanctions in the amount of \$5,000 against Plaintiff and
28 her counsel, but granting Plaintiff leave to amend her Complaint. Plaintiff now requests this Court

We are in receipt of Plaintiff's First Amended Complaint, filed July 14, 2023. Please accept this correspondence as our good faith effort to meet and confer pursuant to Code of Civil Procedure sections 430.41 and 435.5 regarding Mr. Nathan Fletcher's prospective demurrer and/or motion to strike. As discussed in detail below, Plaintiff's First Amended Complaint is subject to a motion to strike given that it contains numerous irrelevant, improper, and immaterial allegations. Additionally, her FEHA claims against Mr. Fletcher are subject to demurrer for failure to sufficiently allege viable causes of action. Please advise no later than the close of business on **Wednesday, August 9, 2023** as to whether Plaintiff will agree to voluntarily dismiss or amend her FAC in accordance with the defects identified below.

I. <u>Motion to Strike</u>

California Code of Civil Procedure section 436 states that a court may strike out any irrelevant, false, or improper matter inserted in any pleading, as well as all or any part of any pleading not drawn or filed in conformity with the laws of this state, a court rule, or an order of the court. (Ca. Code Civ. Proc. \$436(a)-(b)). "Irrelevant" material that may be stricken pursuant to Section 436 includes "immaterial" allegations. (See Cal. Code Civ. Proc. \$431.10 (c).) To this end, an "immaterial allegation in a pleading includes any "allegation that is not essential to the statement of a claim or defense," as well as any "allegation that is neither pertinent to nor supported by an otherwise sufficient claim or defense." (See Cal. Code Civ. Proc. \$431.10 (b)(1)(2)).

Here, Plaintiff's FAC contains numerous words, sentences, and paragraphs that are either irrelevant, improper, or immaterial. For example:

- <u>FAC Paragraph 2</u> states that "...Fletcher is married to former California State Assemblywoman Lorena Gonzalez..." Given that Ms. Gonzalez is not a party to this action and there are no allegations that she participated in – or was even aware of – any conduct described in the FAC, this this statement is wholly irrelevant to any of Plaintiff's claims. It must be voluntarily stricken.
- <u>FAC Paragraph 26</u> states that "Fletcher and his family were living at a hotel in downtown San Diego while repairs were being made to their home. Fletcher's wife, former State Assemblywoman Lorena Gonzalez Fletcher, spent much of her time in Sacramento and other cities throughout California, at which times Fletcher often stayed in San Diego." The general description of Mr. Fletcher's living arrangements and his family's travel plans have no bearing on any of plaintiff's causes of action, nor do they have any probative value to any of the material facts. Thus, this statement is wholly irrelevant to any of Plaintiff's claims. It must be voluntarily stricken.
- <u>FAC Paragraphs 57-68</u> improperly refer to confidential, pre-litigation settlement communications. To this end, the communications are both privileged and inadmissible at trial. For this reason, they are irrelevant and immaterial to all of Plaintiff's claims and must be voluntarily stricken.
- <u>Third Cause of Action for Sexual Assault and Battery</u> Assault and battery are two separate causes of action in California. To this end, each cause of action should be separately stated, must be separately numbered, and must identify against whom it is asserted. (See Ca. Rule of Court 2.112). Plaintiff's failure to follow this rule makes these combined claims both subject to a motion to strike because they are "not drawn or filed in conformity with the laws of this state, a court rule, or an order of the court." (CCP § 436(b)).

II. <u>Demurrer</u>

Several of Plaintiff's causes of action against Mr. Fletcher are also subject to demurrer. In particular, California Code of Civil Procedure section 430.10 provides that a complaint may be subject to demurrer when it does not state facts sufficient to constitute a cause of action. (Ca. Code. Civ. Proc. § 431.10(e)). Here, Plaintiff's FEHA claims against Mr. Fletcher (i.e. Plaintiff's first, fourth, fifth, sixth, and seventh causes of action) fail to state a claim because Mr. Fletcher was not Plaintiff's employer, nor was he an employee of Defendant MTS. Given that Gov. Code § 12940 applies only "unlawful employment practices" perpetuated by "employers," Plaintiff's first, fourth, fifth, sixth, and seventh causes of action are inapplicable to Mr. Fletcher as a matter of law. They must be voluntarily dismissed.

The Demand, which was served after hours last week, provides a deadline of today for our office to dismiss Plaintiff Grecia Figueroa's ("Plaintiff" or "Ms. Figueroa") claims against Fletcher. Be advised that, for myriad reasons discussed herein, our office will *not* be dismissing any claim or party from the case at this time.

Upon reviewing the Demand, we were disappointed yet unsurprised by its oversimplified rendition of the facts. In material ways, your client and your firm appear to gravely misunderstand, or perhaps blatantly ignore, the nuance surrounding consent in sexual harassment/assault cases. Your error underscores much of why we cannot and will not dismiss any claim or party at this early stage of the case. Put simply, your Demand contains *improper* arguments that would be expected much later on in a motion for summary judgment. As a reminder of the status of this case, discovery is still ongoing and no depositions have taken place despite Plaintiff's efforts to schedule them. In fact, we are trapped in a vicious cycle of time-consuming and costly motion work because both defendants – particularly Fletcher – would rather bully Ms. Figueroa than let her speak.

Crucial to this case is the fact that survivors of sexual harassment/assault, like Ms. Figueroa, struggle to find the courage to tell their stories. They feel that they will be dismissed and called liars simply because the truth is at odds with what their perpetrators, like Fletcher, are willing to admit. This is why only about 12% of survivors come forward even though a staggering 81% of women nationwide report experiencing sexual harassment/assault in their lifetime.¹ Despite the characterization of Ms. Figueroa in your Demand, it should be noted that only about 2% of reports of sexual harassment/assault end up being false.² Therefore, just because Fletcher fancies himself a big deal does not mean that his word or his worth are more valid than Ms. Figueroa's word or worth. In fact, the conduct of your client, and indeed your firm, is plainly representative of all too many cases in the #MeToo Movement where men of power think that their influence, resources, and bravado can silence their victims. But this plague of "boys will be boys" is over.

As an observation about your firm's professionalism, it is clear by the slinging of mud at our client and our firm that ethics are conveniently elusive to you. The Pride Law Firm is well-respected for its advocacy of survivors of sexual harassment/assault and employees wronged by their employers. Our attorneys have nearly two decades of experience in these specific practice areas, and have tirelessly fought for justice for our clients. This case is no exception. However, rather than focus on the facts of this case, your firm took the time to research and cite two (2) unrelated and remote instances of sanctions relating to our firm in an attempt to paint Ms. Figueroa's claims as "deceptive." This is an unscrupulous folly. Perhaps we should take the time to further explore *your* firm's history of deceptive litigation tactics, which resulted in substantial sanctions and/or verdicts against you and your clients in the past.³ But what useful purpose would this serve?

Therefore, to refocus, this case is about Ms. Figueroa being wronged by Fletcher and her former employer, San Diego Metropolitan Transit System ("MTS"). This is *not* a case about the frail reputation of a cheating politician whose acts came to light at an inconvenient time in his career. Fletcher, a married man, admits that he engaged in sexual relations with Ms. Figueroa while she was employed by MTS.⁴ Although Fletcher was not Ms. Figueroa's direct supervisor, he was the Chairman of MTS' Board of Directors and carried a great deal of power and influence within the organization and within local government. Even setting aside the complex issue of consent relating to *each and every* act between Fletcher and Ms. Figueroa was terminated the same day Fletcher announced his intent to run for public office. The potential involvement of Fletcher, and perhaps even his wife, California State Assemblywoman Lorena Gonzalez, is yet to be borne out. In sum, there are numerous factual issues that remain, and it is the job of the jury – *not* Fletcher or your firm – to determine the truth.

I. <u>Unequal Power Dynamics Between Fletcher and Ms. Figueroa Led to Ms. Figueroa</u> <u>Feeling Unable to Turn Down Fletcher's Advances</u>

A. The Complicated Psychology of Survivors Like Ms. Figueroa

At the outset, all parties must acknowledge that sexual harassment/assault cases are rarely black and white. The requirement of consent is complicated and multi-faceted, depending on a host of

factual circumstances, and often relying on witness testimonies and expert analyses. As such, the messages between Fletcher and Ms. Figueroa⁵ upon which your Demand *solely* relies cannot possibly be the deciding factor in determining whether *each and every* act or encounter was, in fact, consensual. Most glaringly, your firm hasn't bothered to even depose Ms. Figueroa to attempt to get her side of the story. One can only wonder why. But since you haven't inquired yourselves, we will illuminate you as to why it is so important to understand the psychology of survivors like Ms. Figueroa.

Survivors of sexual harassment/assault, when confronted with their perpetrator, experience a "fight or flight" reaction by the sympathetic nervous system based upon the perception or anticipation of harm. ⁶ In recent decades, however, psychologists and neuroscientists have discovered a somewhat more nuanced response to sexual harassment/assault situations known as the "fawn" response. ⁷ Unlike the traditional "fight or flight" dichotomy, the "fawn" response arises by "[m]any survivors describe[ing] that they 'went along with it,' perhaps as a way to get through it quickly or as a way to keep it from getting worse, which is *not* the same as providing consent."⁸ Put simply, survivors can sometimes "recall certain behaviors that may sound like normal, consensual, sexual acts, but that they resorted to these things because they felt that they had no other choice."⁹ It goes without saying that survivors of sexual harassment/assault feel a litany of emotions, from shame and humiliation to guilt and depression. The "fawning" response only exacerbates these emotions, making the survivor further doubt that they will be believed.¹⁰ Unfortunately, through your Demand, we see this phenomenon of misplaced disbelief in action.

Given these complexities, Ms. Figueroa fully intends to retain one or more experts to opine as to her psychological responses to Fletcher's unwanted sexual advances, as well as her ongoing emotional harm. Specifically, the conduct of the defendants herein has left Ms. Figueroa without meaningful work in her field, which is deeply demoralizing and economically troubling for her. Ms. Figueroa has also suffered and continues to suffer from fear, shame, humiliation, guilt, trouble sleeping, trust issues, depression, and anxiety. On at least one occasion, Ms. Figueroa contemplated suicide and was forced to speak with a suicide hotline.¹¹ To this end, the conduct of Fletcher and your firm throughout this case thus far has only made these symptoms worse.

B. Ms. Figueroa's Contemporaneous Communications with Friends Demonstrate that All or At Least Most of Fletcher's Advances Were Not Consented to by Ms. Figueroa

As you know, our offices have met and conferred extensively regarding initial written discovery. In response to your latest meet and confer letter dated December 27, 2023, and in the spirit of compromise and transparency, our office produced several sensitive documents (each marked confidential), even though the stipulated protective order is still pending with the Court. These documents were produced on January 5, 2024, which was the agreed upon date by the parties. These documents primarily consist of private communications Ms. Figueroa had with her close friends during the incidents with Fletcher.¹² A review of these private communications provides a more thorough picture of the situation and Ms. Figueroa's responses to trauma.

By way of example, the following communications are presented side-by-side to illustrate the complexity of Ms. Figueroa's predicament and her lack of consent. In many instances, Ms. Figueroa expresses concern, fear, and apprehension about her work life with Fletcher around making advances at her.



There are clear examples of "fawning" behavior on the part of Ms. Figueroa as she attempts to pacify Fletcher, while at the same time expressing to those close to her that she is uncomfortable with the situation. On multiple occasions, Ms. Figueroa indicates she is going to muster the courage to tell Fletcher to leave her alone. However, she is afraid of what might happen and afraid of anyone finding out. It is clear that Ms. Figueroa felt trapped and that she had no other choice than to play along with Fletcher; he was, after all, the Chairman of her employer, MTS.

Ultimately, Ms. Figueroa enjoyed her work at MTS; she has a passion for public relations and was hopeful for a long career with MTS. She was terrified that Fletcher might interfere with her career one way or another, or that MTS would find out about the encounters and terminate her. Turns out, her fears came true.

II. <u>Fletcher's Threatened Demurrer and/or Motion to Strike Improperly Seek to</u> <u>Resolve Factual Disputes in the Pleading Stage</u>

Your Demand threatens the filing of a demurrer and/or motion to strike as to Plaintiff's operative complaint, as well as vaguely threatening reporting of our firm to the State Bar. Both threats are misguided attempts to further bully Ms. Figueroa and her counsel. Not only that, but these threats illustrate a lack of good faith.

As to Fletcher's responsive pleading due January 22, 2024, we reiterate that a demurrer and/or motion to strike on the grounds set forth in your Demand would be inappropriate for a number of reasons. *First*, your arguments ignore the nuance of consent and fall into the trap of "blaming the victim" in the face of clearly "fawning" behavior. *Second*, your arguments broadly assert that all interactions between Fletcher and Ms. Figueroa were consensual, when, in fact, we would have to go through each and every encounter to assess consent individually and in light of the circumstances. *Third*, your arguments ignore the totality of the circumstances, including Ms. Figueroa's contemporaneous communications with close friends, the pressures of Ms. Figueroa's employment and how Fletcher could have (and likely did) easily influence it such that she was fired, and the total failure of your office to depose Ms. Figueroa to obtain her sworn testimony as to these matters.

Essentially, these arguments demonstrate your attempt to circumvent the Code of Civil Procedure by having a motion for summary judgment heard at the early pleading stage. We fervently disagree with this tactic and will continue to oppose any such attempts by your office to subject our client to further turmoil simply because you can. Your professionalism and adherence to established rules from here on out would be appreciated.

III. <u>Sanctions Are Appropriate Against Fletcher and Your Firm for Repeated Abuses of</u> <u>the Litigation Process</u>

Despite what mistruths the Demand touts, our office has done nothing but zealously advocate for our client. For example, the Demand claims that we "were aware . . . that [Ms. Figueroa] was a consensual participant in her encounters with Mr. Fletcher." This is preposterous. First of all, no one other than Ms. Figueroa herself could possibly know this for sure since she alone held the power of consent. Moreover, we understand given our extensive experience in this area that the totality of the circumstances must be assessed to properly determine consent as to each encounter. As we have explained herein, your Demand fails to consider other factors aside from the messages between Fletcher and Ms. Figueroa. However, they don't tell the whole story.

Your Demand also suggests that our office intentionally, and without good cause, withheld "exonerating" documents from Fletcher. The "exonerating" documents we assume you refer to are the message between Fletcher and Ms. Figueroa – messages that Fletcher should himself have access to as he was a participant. Not only that, but the parties had not yet agreed upon the terms of a stipulated protective order, which meant that any sensitive documents could not be produced yet. Ultimately, these documents, and even further documents, were produced despite the stipulated protective order still being pending. We have attempted to protect our client's Constitutionally protected privacy rights to the extent possible, while also complying with our discovery obligations.

Your office, however, has *not* acted in good faith. For example, all sets of written discovery propounded upon Fletcher have been deficient (as per our meet and confer correspondences dated September 7, 2023 and December 20, 2023), and yet your office refuses to provide supplementation. If this trend continues, we will have no choice but to move to compel Code-

compliant responses. In addition, your office has needlessly propagated motion practice at the expense of all parties and the Court's time, including frivolous motions to strike and utilizing basic (and televised) status conferences as a platform to manipulate the narrative of the case. This is all no coincidence. It is a blatant attempt to shame a survivor, Ms. Figueroa, to try to save Fletcher's reputation. However, Ms. Figueroa didn't destroy Fletcher's reputation – he did that himself through infidelity, recklessness, and alcohol abuse.

Given the foregoing, and should the abuses of the litigation process continue, Plaintiff will seek all appropriate remedies available to her, including a request for monetary sanctions against Fletcher and his attorneys at Fisher Phillips, including Danielle Moore, Stephanie Reynolds, Sean McKaveney, and Keia Atkinson.

IV. <u>Next Steps</u>

For the foregoing reasons, Plaintiff cannot and will not dismiss any claim or party from the case at this time. Quite simply, there are too many unresolved factual disputes that the parties must contend with, including the totality of the circumstances surrounding each and every sexual encounter between Fletcher and Ms. Figueroa. To this end, Ms. Figueroa will continue to engage in the discovery process to prove her claims, including re-noticing the depositions of Fletcher, Lorena Gonzalez, and other percipient witnesses.

In light of all this, we encourage you to meet and confer further with our office. Again, the goal is not to needlessly engage in motion practice. If, however, your office proceeds with its frivolous motion(s), or should your evasiveness with discovery persist, we will have no choice but to seek all available remedies, including monetary sanctions. The abuses of our client and the litigation process must stop.

One thing that I want to bring to your attention is that your firm continues to fail to produce documents to our firm that you serve on Mr. Fletcher's. So, far this is at least the second or third time that we have learned that you have produced documents to Mr. Fletcher's counsel but have failed to provide them to Meyers Nave. If you change your mind about having a reasonable meet and confer conference, I would appreciate it if we could just assure that you have properly served us with all of the documents, as we have missed at least two (maybe three) such productions. Janice,

We brought up depositions months ago. This is just me revisiting now that we've had multiple rounds of discovery, motion practice, tv reporting, etc. You or your clients' commitments are not of a general concern to me. If there are specific dates you or your clients aren't available, then please, don't offer those dates. But a general: "I just don't want to provide any dates until we have a phone conversation" is not how this works. Per the Code, I have the right to notice depositions when I see fit; not when you see fit. I am trying to work with you on dates, but you are flat out refusing to provide them. I will ask once more so that there is absolutely no confusion with our motions relating to the depositions:

> Does MTS still employ Jeff Stumbo and Mark Olsen? If so, I would like deposition dates in February or March. Please provide available dates by Monday of next week. If you are unwilling to provide dates of availability for deposition, we will be forced to set unilaterally. We would like not to have to do that and we would also like to avoid motion practice as it relates to our right to conduct discovery/depositions.

So you see Janice, if my office sets dates unilaterally it will be because you forced me to do so by failing to respond to a simple inquiry about availability. Now if you are telling me that NONE of your clients are or will be available for deposition anytime in either February or March, that is a different statement and we can deal with that in turn. But without more information from you, I have to assume that you are just refusing to cooperate in discovery.

Mr. McKaveney,

I would also like dates of availability for deposition for unemployed Defendant Nathan Fletcher and his wife Lorena. Do you intend to represent Lorena in her deposition, or should I subpoena her directly? I would prefer dates in February, but will take dates in March if no February dates are available. Please provide said availability by Monday. Also, please let me know if you also intend to refuse to provide deposition availability for your clients. Thanks.
