I, Ryan J. Foreman, declare I am a Deputy City Attorney employed by the San Diego City Attorney's Office, and I have read and reviewed the official reports for case 19018759 of the San Diego Police Department made by Detective Garren, I.D. No. 5945, which state the following:

On April 30, 2019, Bruno Amadeo Schonian (Defendant) who is an adult teacher at Roosevelt Middle School, told his former student [REDACTED] (Victim) a minor that they should hang out some time. Defendant asked Victim if she could memorize his phone number and then provided her with his phone number to memorize. Defendant told Victim to only call him from a pay phone and not to call him from any phone that would create "digital" evidence. Defendant asked Victim if she was allowed to go to Plaza Bonita shopping mall alone, and if so, offered to meet there to go shopping, hang out. Defendant repeatedly told Victim that she could not tell anyone about them "hanging out" because he could get in trouble. On previous occasions, Defendant told Victim she had really pretty hair, and she should not date ugly boys. Defendant's comments made Victim very uncomfortable.

Defendant admitted to Detective Garren that he had given his phone number to the Victim, and had discussed meeting up.


WHEREFORE, your declarant prays for the issuance of a warrant for the arrest of the above-named defendant for violation of Penal Code section 647.6(a)(1).
