I can definitely get this done for you. One question I have is are you wanting [REDACTED] [REDACTED] surveilled concurrently for 4 days?

I am out of town April 4-8th. I could possibly do April 9-12, but it may have to be the following week. Is there any deadline?

As far as the surreptitious filming, it sounds like I would have to be out of my vehicle and in plain view, is that correct? If that is the case, I would likely just use a cell phone. But they probably wouldn't realize I was taking pictures or video, unless I made it blatantly obvious. The other option would be to not film/photograph the child, but we could put in a written report that the child was observed, with whom they were observed, what vehicle they were observed in, and that they were observed being dropped off at school in the same vehicle. Would that suffice? We could also obtain video of the vehicle and possibly the person the child is with without filming the child. Can you please advise further on that so that we obtain evidence that you are able to use?

For purposes of this policy, "surreptitious photographing or video-recording" means the covert collection of photographic or videographic images of persons or places subject to an investigation. For purposes of this policy, the collection of images is not covert if the technology is used in open and public view.
  - b. Require that the employees and contractors of the District engaged in the investigation must identify themselves truthfully as such to individuals contacted or interviewed during the course of the investigation.

I received your email this morning. I am forwarding you all previous emails from Marley Nelms and myself regarding this matter. Contract agreements from DMUSD were signed.

What I need to proceed is a signed retainer agreement, payment, all of the Subject information (name, DOB, address, vehicle information, and any other pertinent details you may have about the Subject).
